[REDACTED] is hereby authorized to assume the name of (First) **CHARLIE** (Middle) **MARION** (Last) **KERR** in place and stead of his/her present name upon complying with the provisions of Article 6 of the Civil Rights Law and of this Order.

2) This Order, consisting of a total of 2 page(s), shall be entered, and the Petition upon which it was granted shall be filed, prior to the publication hereinafter directed, in the office of the Clerk of the Civil Court of the City of New York, County of New York.

3) Within sixty days of the making of this Order, a copy of this Order and supporting papers shall be served upon the following:

- Selective Service System
- Social Security Administration

PLEASE NOTE: This name change does not constitute proof of change in gender.

4) Proof of service on the above indicated party(ies) shall be filed with the Clerk of this Court within ninety days of the making of this Order.

5) At least once within sixty days of the making of this Order, a notice shall be published in El Diario-LA Prensa (Spanish) newspaper(s) in substantially the following form:

7) Following the filing of the Petition and the entry of this Order as directed in Paragraph 2 above; the service of such Order and such papers as directed in paragraph 3 above; the filing of proof of such service as directed in Paragraph 4 above; the publication of such notice as directed in Paragraph 5 above; and the filing of proof of such publication as directed in Paragraph 6 above, it is further **ORDERED** that (First) **CHARLES** (Middle) **MARSHALL** (Last) **KERR** AKA **CHARLES KERR** and AKA **CHARLES M. KERR** shall be known by the name (First) **CHARLIE** (Middle) **MARION** (Last) **KERR**, which s/he is hereby authorized to assume.
